Question 1

- **B1** selecting option A, which correctly identifies Purgatory as a temporary state of purification for those who will enter heaven, oe
- **Answer: A, a temporary state of purification for those destined for heaven.**

Question 2

- **B1** praying for the souls of the dead, oe
- **B1** offering Masses or Requiem Masses for the repose of a soul, oe
- **Answer: Praying for the dead; offering Masses or a Requiem Mass for the dead.**

Question 3

- **B1** point 1: Purgatory purifies the soul from venial sins or remaining attachment to sin so the soul can enter the presence of God, oe
- **B1** development: this purification removes what would prevent full communion with God in heaven, making the soul holy and ready, oe
- **B1** point 2: Purgatory allows for temporal punishment to be completed after death, distinct from eternal punishment, oe
- **B1** development: Catholics understand this as corrective and merciful, not permanent condemnation, so prayer and Masses can help the soul, oe
- **Answer: E.g. it purifies souls from venial sin and attachments so they can fully enter God's presence; it completes temporal punishment in a merciful way distinct from eternal condemnation, and allows the living to help by prayer and Mass.**

Question 4

- **B1** belief 1: Catholics teach that some souls undergo Purgatory to be purified before entering heaven, oe
- **B1** development: this belief is affirmed by the Council of Trent and reflected in practice such as the Requiem Mass, oe
- **B1** belief 2: many Protestants reject Purgatory, teaching that after death a person is judged and goes directly to heaven or hell, oe
- **B1** development: this rejection is based on sola scriptura and sola fide, the Reformers argument that salvation is by faith alone and that the Bible does not teach Purgatory, oe
- **B1** a correct and explicit reference to a source of wisdom and authority, e.g. Council of Trent as Church teaching or 1 Corinthians 3:15 as sometimes used in support, oe
- **Answer: Contrast: Catholics teach purification in Purgatory, affirmed at the Council of Trent and reflected in prayers for the dead; many Protestants reject Purgatory because of sola scriptura and sola fide, arguing the Bible does not require an intermediate purification. Reference: Council of Trent; 1 Corinthians 3:15 is a biblical text sometimes cited in the debate.**

Question 5

- **B1** Catholic Requiem includes Mass and prayers for the repose of the soul, oe
- **B1** Catholic liturgy may include intercessions and absolution for the dead, whereas Protestant committal is often shorter and focuses on commendation to God, oe
- **B1** Protestant service is often a simple committal with emphasis on immediate life with or judgement by God and less on intercessory rites for the dead, oe
- **Answer: Any three: Requiem Mass with prayers for the dead; intercessions and absolution are common in Catholic liturgy; Protestant committal is often shorter and focuses on commendation and remembrance rather than intercessory rites.**

Question 6

- **B1** identifying 1 Corinthians 3:15 and noting it is used to suggest a purifying loss that nevertheless leads to salvation, oe
- **Answer: 1 Corinthians 3:15, used to suggest a purifying experience where a person is saved but as through fire, which some interpret as support for Purgatory.**

Question 7

- **B1** point 1: sola fide, the Protestant belief that salvation is by faith alone, so no further purification after death is necessary for the justified, oe
- **B1** development: Reformers argued that if justification is complete in Christ, Purgatory undermines the sufficiency of Christ's atonement, oe
- **B1** point 2: sola scriptura, the Protestant principle that the Bible alone is the final authority, and that the Bible does not clearly teach Purgatory, oe
- **B1** development: because Purgatory is not explicit in canonical scripture according to many Protestants, they reject the doctrine and related practices like indulgences, oe
- **Answer: E.g. sola fide: salvation by faith alone means no post-death purification is needed; sola scriptura: lack of clear biblical teaching on Purgatory leads Protestants to reject it and practices associated with it.**

Question 8

- **B1** reason 1: Catholics believe the communion of saints means the living and the dead are united in Christ, so the living can intercede for the dead, oe
- **B1** development: this unity is taught in Catholic tradition and explains why prayers and Masses can aid the purification of souls, oe
- **B1** reason 2: Church authority, including the Council of Trent, upholds the practice of offering Masses for the dead as beneficial, oe
- **B1** development: this official teaching supports the idea that sacred actions by the living can apply spiritual benefit to the souls undergoing purification, oe
- **B1** explicit reference to Church teaching or tradition, e.g. Council of Trent or the idea of the communion of saints, oe
- **Answer: E.g. belief in the communion of saints means the living can intercede for the dead and help their purification; Church teaching such as the Council of Trent affirms offering Masses for the dead as beneficial.**

Question 9

- **B1** the development of prayers and Masses for the dead to meet pastoral concerns about loved ones after death, oe
- **B1** the theological development and emphasis by medieval theologians on the need for post-death purification and the efficacy of prayers, oe
- **Answer: E.g. pastoral concern led to prayers and Masses for the dead; medieval theological development emphasised post-death purification and the efficacy of intercession.**

Question 10

- **B1** Catholics might hold a Mass or say prayers specifically for the soul's repose, oe
- **B1** Protestants might hold a memorial service or give thanks for the persons life without offering intercessory rites for purification, oe
- **B1** Catholics may observe anniversaries with Masses for the dead, while Protestants may mark anniversaries with acts of remembrance or charitable giving, oe
- **Answer: Three: Masses and prayers for repose in Catholic homes/parish; Protestant memorial services that focus on thanksgiving and remembrance; Catholics may observe anniversaries with Masses whereas Protestants may remember with acts of service.**

Question 11

- **B1** point 1: it offers hope that imperfectly lived believers are not immediately condemned and can be purified and reunited with God, oe
- **B1** development: this can comfort grieving families who believe their loved one can be aided by prayer, oe
- **B1** point 2: it provides a sense that Christian practice continues to matter after death, giving meaning to intercessory rites and remembrance, oe
- **B1** development: believing that the living can benefit the dead encourages ongoing pastoral actions such as Masses and charity, oe
- **Answer: E.g. offers hope of purification and reunion rather than immediate condemnation, comforting grieving families; gives meaning to ongoing practices so the living can help the dead, supporting pastoral care.**

Question 12

- **Level 1** (1-3): A few simple points are made for or against the view with little development or reference to religious ideas. The judgement, if any, is unsupported.
- **Level 2** (4-6): Some developed arguments for and against the view are given, with some reference to religious teaching or practice. A simple conclusion is offered.
- **Level 3** (7-9): Clear and developed arguments are presented for and against the view, with accurate reference to Christian teaching and practice and some evaluation of the points. A supported conclusion is reached.
- **Level 4** (10-12): A thorough, balanced and well-focused evaluation showing detailed reasoning for and against the view, precise reference to relevant Christian teachings or scripture, and a clearly justified and well-explained conclusion.
- **Level 0** (0): No relevant material.
- **Indicative content:**
 - Arguments that support the statement might include: Purgatory is not explicitly taught in many Protestant readings of scripture and so can divide Christians; belief in Purgatory can be misunderstood as suggesting deeds rather than faith earn salvation, clashing with sola fide; the doctrine has historically been associated with abuses such as the sale of indulgences, which can make it seem unhelpful or harmful.
 - Arguments against the statement might include: Purgatory provides pastoral comfort and hope that imperfect believers can be purified and enter heaven; it gives meaning to prayers and Masses for the dead and supports communal responsibility and the communion of saints; Church teaching such as the Council of Trent and biblical texts like 1 Corinthians 3:15 are used to justify the belief within Catholic tradition.
 - Religious arguments should include reference to Catholic teaching and practice, the Council of Trent, and the Reformers principles of sola scriptura and sola fide as a Protestant basis for rejection. Reference to 1 Corinthians 3:15 as a biblical text sometimes used in discussion is appropriate.
 - Evaluation might weigh pastoral benefits against theological problems and possible abuses, consider ecumenical implications of holding or rejecting Purgatory, and reach a reasoned judgment about whether the belief is helpful in contemporary Christian life.
